October 24, 2024

I. Call to Order and Roll Call

Chair Friedman called the October 24, 2024 Central Coast Water Authority (CCWA) Board of Directors meeting to order at 9:00 AM.

Upon a motion by Director Cordero, seconded by Director Clay and carried with Directors, Clay, Cordero, Friedman, Sanchez and Werner in favor and none opposed the Board approved the Consent Calendar.

IV. Executive Director's Report

A. State Water Project Water Supply Issues Overview

Dr. Chandra Chilmakuri, Assistant General Manager for Water Policy at State Water Contractors, provided a presentation on the hydrology of California, historical rainfall and sources of water throughout a typical water year, as well as the impacts of climate change and the actions taking place to accommodate those impacts. Regulations related to fish and water quality and their effect on the State Water Project (SWP) water allocation were reviewed.

The outlook for ongoing operations of the SWP using modeling for the estimated impact of the Healthy Rivers and Landscapes Program and the Delta Conveyance Project were also reviewed.

B. Consider Amendment of the Minutes of April 25, 2024 Board Meeting

A revision of the minutes of the April 25, 2024 Board Meeting was requested to correct the omission of the Executive Director's receipt of an additional week of administrative leave.

Upon a motion by Director Clay, seconded by Director Cordero, and carried with Directors Clay, Cordero, Friedman, Johnson, Sanchez and Werner in favor and none opposed the Board approved the requested correction to the minutes of April 25, 2024.

C. CCWA Water Supply Situation

Mr. David Beard, CCWA Deputy Director of Operations and Engineering, provided the Water Supply Situation Report presentation which reviewed the expected precipitation for the upcoming water year as well as rainfall within State Water Project watersheds, storage levels within San Luis Reservoir. He also provided an update related to the amount of carryover water allowed in San Luis Reservoir as well as pending water transfer agreements.

D. Request for Approval of Carryover of Project Funds from FY 23/24 to FY 24/25 - \$2,510,121.53

Mr. Beard reviewed the staff report listing capitalized and expensed projects that are requiring more than one year to complete and requested carryover of project funds from last fiscal year to the current fiscal year in the total amount of \$2,510,121.53.

Upon a motion by Director Sanchez, seconded by Director Johnson and carried with Directors Clay, Cordero, Friedman, Johnson, Sanchez and Werner in favor and none opposed the Board approved the request to carryover project funds in the amount of \$2,510,121.53 as detailed in the staff report.

E. FY 2024/25 First Quarter Investment Report

Ms. Dessi Mladenova, CCWA Controller, reported as of September 30, 2024, the investment portfolio totaled \$66.2 million and had an effective rate of return of 5.14% on an average daily balance for the month of September 2024 of about \$68.9 million. The investments were comprised of Montecito Bank & Trust money market accounts (\$1.9 million), Charles Schwab market funds of \$38.9 million and Treasuries of \$25.4 million.

All investments during the quarter complied with the CCWA investment policy provisions and current pro forma projections indicate that the Authority will have sufficient cash with which to operate for the next six months.

Upon a motion by Director Johnson, seconded by Director Sanchez and carried with Directors Clay, Cordero, Friedman, Johnson, Sanchez and Werner in favor and none opposed the Board accepted the first quarter FY 2024/25 investment report.

F. CCWA Meeting Dates for 2025

A memo listing the regular scheduled meeting dates for calendar year 2025 was included in the materials for the information of the Board.

G. State Water Contractors Report

State Water Contractors (SWC) have continued their efforts on the Healthy Rivers and Landscapes Program and gearing up towards a decision on the \$10/AF change on deliveries to State Water Contractors. In October the SWC will meet in Santa Barbara County and tour Cachuma facilities. Mr. Stokes noted that a Federal lobbyist has been hired by SWCs.

Note 3: DWR Reserve Fund

The DWR Reserve Fund was established to provide a funding source for payments to the State of California Department of Water Resources (DWR) when there is a difference between estimates used to prepare the DWR portion of the annual CCWA budget and the actual amounts billed to the Authority by DWR. Contributions to the DWR Reserve Fund are voluntary. Funding of each participating Project Participant's share of the DWR Reserve Fund will come from a combination of (1) CCWA Operating Expense budget surpluses, if any (2) Interest earnings on funds held in all other accounts on behalf of the participating Project Participant and (3) excess amounts, if any, from any of the DWR Statement of Charges cost components until the funding Target Amount is reached. The Target Amount will be equal to the participating Project Participant's proportional share of a \$10 million allocation of DWR Transportation Minimum OMP&R charges. SUBJECT: Solstra California Communities LLC's Solomon Hills Project

SUMMARY

Solstra California Communities LLC (Solstra) proposes the development of approximately 1,900 acres in the Solomon Hills region of Santa Barbara County ("**Project**"). Solstra has requested CCWA's cooperation and preparation of certain studies and investigations in order to evaluate the use of imported water to serve the Project. The delivery of any imported water supply to the Project, directly or indirectly, would require conveyance of the supply through the State Water Project ("**SWP**") and CCWA's own facilities and therefore may require CCWA approval.

RECOMMENDATION

Staff recommends that the Board of Directors:

- Approve the January 15, 2025 Waiver of Conflict of Interest letter from CCWA counsel, Stephanie Hastings, Brownstein Hyatt Farber Schreck, LLP re. Brownstein's concurrent representation of CCWA and Solstra California Communities LLC (Attachment 1) and authorize Executive Director to execute it; and
- 2. Approve Cost Reimbursement Agreement between CCWA and Solstra California Communities LLC (**Attachment 2**) and authorize the Executive Director to execute it; and
- 3. Find that pursuant to CEQA Guidelines Section 15262, CCWA's approval of the Cost Reimbursement Agreement is exempt from California Environmental Quality Act (CEQA) and therefore does not require the preparation of any environmental documentation because it involves only feasibility or planning studies for possible future actions which CCWA or its Board has not approved, adopted, or funded. Furthermore, execution of the Cost Reimbursement Agreement will not have a legally binding effect on later governmental approvals, and does not commit CCWA to the Project, consistent with Save Tara v. City of West Hollywood (2008) 45 Cal.4th 116 and related jurisprudence; and
- 4. Authorize the Executive Director to develop and draft any policies that may be required in advance of the Board's consideration of any future proposal to convey any supplemental imported supply through CCWA's facilities and bring such policies back for the Board's consideration at a future meeting.

DISCUSSION

Background

Solstra proposes the development of approximately 1,903 acres in the Solomon Hills region of Santa Barbara County between Highways 101 and 135. The Project would include a new community that will consist of 4,000 residential units, a Village Center, an estimated 500,000 to 600,000 square feet of office campus, and between 1,000 to 1,200 acres of open space, conservation easements, parks, and trails. Land use approvals, including a General Plan Amendment and rezones, are pending with Santa Barbara County. The County will act as the "lead agency" for compliance with CEQA.

Solstra is considering various water supplies to serve the Project, including but not limited to SWP water and/or other imported supplies (individually and collectively, "**Imported Supply**"). The delivery of any Imported Supply to the Solomon Hills Project, directly to Solstra or to a CCWA Participant which agrees to serve the Project, would require conveyance of the supply through the SWP and CCWA's own facilities. Depending on the transaction, CCWA approval may be required.

Waiver of Conflict of Interest

CCWA's legal counsel, Brownstein Hyatt Farber Schreck, also represents Solstra with respect to the Project. When Solstra requested CCWA's cooperation with respect to the evaluation of an Imported Supply to serve the Project, Brownstein notified both CCWA and Solstra of the potential for conflicts of interest between them and requested both clients' consent to Brownstein's concurrent representation of both clients and waiver of any conflicts of interest should they arise.

Solstra has consented to Brownstein's representation of CCWA in any relations or transaction with Solstra and/or involving the Project and has retained separate counsel to represent its interests in any relations or transactions with CCWA.

Brownstein requests CCWA's consent as well, as more particularly described in Attachment 1.

Cost Reimbursement Agreement

The proposed Cost Reimbursement Agreement presented for the Board's review (Attachment 2) sets forth the terms and conditions of Solstra's reimbursement of CCWA for any costs and expenses incurred by CCWA with respect to the Project.

To avoid any situation in which CCWA staff incurs costs and expenses that are not paid, the proposed Cost Reimbursement Agreement would require Solstra to make advance payment for all costs and expenses by providing CCWA with a deposit of \$25,000 prior to CCWA undertaking any work, and further to replenish the deposit as needed to cover any additional requested work by CCWA. The proposed Cost Reimbursement Agreement provides for Solstra's full reimbursement of CCWA's costs for staff time and expenses (including legal fees), as well as indemnification and defense of CCWA in the event any liability arises out of Solstra's investigation and evaluation of the use of any Imported Supply to serve the Project.

Policy(ies) for the Wheeling or Other Conveyance of Imported Water

To date, CCWA has not had occasion or need to develop any policy(ies) relating to the conveyance and delivery of any imported supply that is not CCWA's existing SWP supply

(consisting of 45,486 AF of "Table A Allocation" and other SWP supplies made available by the Water Supply Contract with the Department of Water Resources).

Preliminary discussions with Solstra suggest that one or more options Solstra is considering to serve the Project may necessitate the adoption of a policy by CCWA's Board, for example to set the rates, charges, and other conditions for wheeling any non-SWP supplies through CCWA facilities.

CCWA will draft and propose for the Board's consideration any policies necessary or beneficial to considering any future request by Solstra to convey any Imported Supply through CCWA facilities.

ENVIRONMENTAL REVIEW

CCWA's approval of the Cost Reimbursement Agreement is exempt from CEQA pursuant to CEQA Guidelines Section 15262, because it involves only feasibility or planning studies for possible future actions which CCWA or its board has not approved, adopted, or funded and does not require the preparation of an EIR or negative declaration at this time. Approval of the Processing Agreement in no way commits CCWA to convey any supply of water to the Project; rather, it merely provides a mechanism for the funding of certain pre-Project investigations and studies. Any future approval of the Project taken by the lead agency and any responsible agenc(ies) will require compliance with CEQA.

RE: Waiver of Conflict of Interest - Consultation, Disclosure, Informed Consent

Dear Mr. Stokes:

This letter requests a waiver from Central Coast Water Authority (together with its affiliates and subsidiaries, "CCWA") with regard to a conflict of interest involving Brownstein Hyatt Farber Schreck, LLP's ("Brownstein") representation of Solstra California Communities LLC (together with its affiliates and subsidiaries, "Solstra"), as described below.

Brownstein represents Solstra in a variety of legal matters, including matters relating to the entitlements, environmental compliance, water supply and water service in relation to Solstra's proposed residential Solomon Hills project in Santa Barbara County (the "Project") (collectively, the "Solstra Matters"). Separately, Brownstein serves as counsel to CCWA. CCWA operates the Coastal Branch of the State Water Project that connects the State Water Project to Santa Barbara and San Luis Obispo County. CCWA also owns and operates the water treatment and delivery system that allows for the delivery of State Water Project water and other imported water supplies to retail water providers and other users within Santa Barbara and San Luis Obispo Counties (collectively, "CCWA Facilities"). Brownstein represents CCWA with respect to all matters involving the State Water Project and the CCWA Facilities, among other things.

Now, Solstra is considering various water supplies to serve the Project, including but not limited to State Water Project water and/or other imported supplies. One or more of these potential supplies may require delivery through the State Water Project and CCWA Facilities to the Project. Solstra has retained separate legal counsel in connection with all transactions and/or negotiations with CCWA relating to the Project, the State Water Project and the CCWA Facilities. Brownstein will represent CCWA in any negotiations with Solstra regarding the Solstra Matters/Project, including delivery of State Water Project water and/or other imported water supplies through the State Water Project and CCWA Facilities to the Project. Further, Brownstein will continue to accept engagements from CCWA in connection with any future transactions and/or negotiations with Solstra on matters that may be unrelated to the Project, but in which Solstra may be or may become involved as an adverse party. All such CCWA matters involving Solstra are referred to herein as the "CCWA Matters." Our

representation of CCWA in the CCWA Matters while we represent Solstra in the Solstra Matters arguably constitutes a conflict of interest under the applicable Rules of Professional Conduct.

Under the Rules of Professional Conduct, we may not represent a client in a manner that is adverse to another client unless both clients agree to the proposed representation after being adequately informed, in writing, of the relevant circumstances and the material, reasonably foreseeable ways that the conflict could have adverse effects on their interests.

CCWA should consider whether there is any material risk that Brownstein will be less zealous or eager on its behalf due to Brownstein's representation of Solstra as its counsel and in the Solstra Matters, or whether the professional judgment of Brownstein attorneys working on CCWA's Matters could be affected by the interests of Solstra. We do not believe that there is a material risk of any of the foregoing in our concurrent but separate representation of CCWA as its counsel in the CCWA Matters and Solstra in the Solstra Matters.

As described above, Solstra has retained other legal counsel in connection with all transactions and/or negotiations with CCWA relating to the Project, the State Water Project and the CCWA Facilities. If a conflict of interest between CCWA and Solstra arises with respect to Brownstein's representation of CCWA as its counsel or with respect to the CCWA Matters, Brownstein will continue to represent CCWA, including in any litigation that arises between CCWA and Solstra. Solstra has waived any right to contest Brownstein's continued representation of CCWA or to seek disqualification or recusal of Brownstein from its representation of CCWA, even if Brownstein is representing CCWA in matters that are adverse to Solstra.

Further, if a conflict of interest between CCWA and Solstra arises with respect to the Solstra Matters/the Project, Brownstein will not represent Solstra in such matter adverse to CCWA. However, in that circumstance, CCWA agrees that Brownstein will continue to represent Solstra in any matter relating to the Solstra Matters/the Project that does not involve CCWA. CCWA waives any right to contest Brownstein's continued representation of Solstra or to seek disqualification or recusal of Brownstein from its representation of Solstra in matters relating to Solstra Matters/the Project that do not involve CCWA.

If you have any questions or concerns about the circumstances described herein, please contact me. We recommend that CCWA seek independent counsel regarding the effect of this waiver. If CCWA determines, based on the advice of its independent counsel or otherwise, that our representation as described herein will be detrimental to its interests, CCWA should not consent to it.

If CCWA wishes to consent to this waiver after such review as you believe appropriate, please sign a copy of it in the space provided and return it to the undersigned. Your execution of this letter will

COST REIMBURSEMENT AGREEMENT

This Cost Reimbursement Agreement ("**Agreement**") is made as of January 23, 2025 by and between:

CENTRAL COAST WATER AUTHORITY ("CCWA")

and

SOLSTRA COMMUNITIES CALIFORNIA LLC ("SOLSTRA")

(each, a "Party," and together, the "Parties").

RECITALS

- A. CCWA is a joint exercise of powers agency duly organized and existing pursuant to the Joint Exercise of Powers Act commencing with California Government Code section 6500 et seq. CCWA's members are cities and water districts located in the county of Santa Barbara. Pursuant to the Transfer of Financial Responsibility Agreement, the Santa Barbara County Flood Control and Water Conservation District ("SBCFCWCD") transferred to CCWA, and CCWA accepted and assumed, all rights and obligations to the 1963 Water Supply Contract between the Department of Water Resources and SBCFCWCD that provides for the delivery of water from California's State Water Project ("SWP") to the county of Santa Barbara ("SWP Contract").
- B. CCWA owns, operates and maintains water conveyance, storage and treatment facilities ("CCWA Facilities") connecting the SWP to the counties of San Luis Obispo and Santa Barbara and treats and delivers water from the SWP to cities, water districts and other water purveyors and users in the county of Santa Barbara (each a "CCWA Participant") and also to the San Luis Obispo County Flood Control and Water Conservation District.
- C. Solstra is the owner of certain land in unincorporated Santa Barbara County and is in the process of seeking entitlements and approvals for up to 4,000 residential dwelling units and ancillary commercial uses ("Solomon Hills"). Solstra will be responsible for providing retail water service to customers at Solomon Hills through its own legal entity or partnering with a public water system ("Project"). Pursuant to the California Environmental Quality Act ("CEQA"), the county of Santa Barbara is the lead agency for the Project.
- D. Solstra is considering various water supplies to serve the Project, including but not limited to SWP water and/or other imported supplies (individually and collectively, "Imported Supply"). The delivery of any Imported Supply to the Project, directly or indirectly, would require conveyance of the supply through the SWP and CCWA Facilities and therefore may require CCWA approval.

- E. Solstra has requested CCWA's cooperation and preparation of certain studies and investigations as may be necessary or convenient to Solstra's development and evaluation of any Imported Supply to serve the Project. Solstra has agreed to pay all of CCWA's costs and expenses arising out of or related to such cooperation, investigation, and evaluation in accordance with the terms and conditions of this Agreement and the Parties desire to enter into this Agreement to set forth the terms and conditions of Solstra's payment of such costs and expenses.
- F. In the event Solstra elects to pursue the conveyance and delivery of any Imported Supply to serve the Project, a new agreement between them will be required for that purpose.
- **NOW, THEREFORE**, in consideration of the foregoing recitals, the mutual representations, warranties, covenants and agreements contained in this Agreement, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

1. Solstra Payment of CCWA Costs

1.1 CCWA Costs. Regardless of whether the Project is undertaken or completed by Solstra, Solstra agrees to pay 100% of CCWA's costs and expenses arising out of or related to CCWA's cooperation and preparation of certain studies and investigations as may be necessary or convenient to Solstra's development and evaluation of Imported Water to serve the Project, including but not limited to, CCWA staff time and expenses, the services of CCWA contract employees, administrative costs, consultant fees and costs, attorneys' fees and costs, and any fees and charges of any governmental or quasi-governmental authority (collectively, "CCWA Costs"). Solstra further agrees to pay for all CCWA Costs incurred prior to the Effective Date of this Agreement.

1.2 Advance Payment; Deposit

- 1.2.1 Solstra agrees to pay CCWA Costs in advance of CCWA incurring such costs. Concurrent with Solstra's execution of this Agreement, Solstra shall deposit with CCWA \$25,000 as an advance payment for CCWA Costs.
 - 1.2.2 CCWA shall charge 100% of the CCWA Costs against Solstra's deposit.
- 1.2.3 Periodically, in the sole and absolute discretion of CCWA's Executive Director, CCWA may request that Solstra make additional deposits of funds as necessary to ensure advance payment for anticipated additional CCWA Costs. Solstra shall place on deposit with CCWA the amount stated in the request for additional deposit no later than the deadline established by CCWA's Executive Director.
- 1.2.4 Solstra acknowledges and agrees that CCWA shall have no obligation whatsoever to incur CCWA Costs of any kind or amount if Solstra's deposit is depleted at any time and not replenished by Solstra, even if delays in the investigation, evaluation, processing or consideration of the Project result.

- 1.3 Accounting of CCWA Costs. On a monthly basis or such other periodic basis as CCWA's Executive Director may determine, CCWA shall a deliver a statement of charges itemizing CCWA Costs incurred, including any consultant and legal fees, provided however, that CCWA shall not be required to include privileged and confidential communications to Solstra. The statement of charges shall identify the amount (in \$s) deducted from Solstra's deposit and any deposit balance remaining against which future CCWA Costs will be applied.
- **1.4 Reconciliation.** Upon termination of this Agreement, CCWA shall provide to Solstra an accounting of the total CCWA Costs incurred and Solstra is obligated to pay. Any deposit remaining in Solstra's account with CCWA shall be promptly refunded by CCWA to Solstra.
- 2. <u>Solstra's Representative</u>. Concurrent with execution of this Agreement, in the signature block of this Agreement, Solstra shall identify and provide the contact information for its authorized representative ("Authorized Representative"). Solstra represents and warrants that its Authorized Representative has full authority to grant, provide and enter into, by and on behalf of Solstra, any and all consents, approvals, instructions, authorizations or agreements in connection with this Agreement (collectively, "Solstra Directions"). CCWA shall be entitled to rely upon, without inquiry, the full authority of Solstra's Authorized Representative. Without limiting the foregoing, Solstra's Authorized Representative shall be solely responsible for requesting and obtaining in advance any special or further authorizations that may be necessary in connection with any Solstra's Directions given to CCWA hereunder and CCWA may assume, without further inquiry, that all such authorizations have been obtained. Solstra may designate a different individual as its Authorized Representative in connection with this Agreement at any time by providing written notice to CCWA.

3. <u>Liability, Indemnification, and Defense</u>

- 3.1 Disclaimer of Liability. Solstra acknowledges and agrees that CCWA's cooperation, investigation, and evaluation of any Imported Supply to serve the Project is undertaken in exchange for Solstra's full reimbursement of CCWA Costs and full assumption of any and all liabilities arising out of or related to this Agreement and/or the Project. As a result, it is the intent and agreement of the Parties that, to the maximum extent permitted by law, neither CCWA, nor any of its elected officials, officers, agents, employees, consultants, or attorneys, nor any CCWA Participant, nor any CCWA Participant's elected officials, officers, agents, employees, consultants, or attorneys shall be liable to Solstra for any claims, liabilities, damages, losses, actions, penalties, proceedings, or expenses related to or arising out of this Agreement and/or the Project.
- 3.2 Indemnification. Solstra ("Indemnifying Party") agrees to indemnify, defend, protect and hold harmless CCWA and its elected officials, officers, agents, employees, consultants, or attorneys and all CCWA Participants and each CCWA Participant's elected officials, officers, agents, employees, consultants, or attorneys (each an "Indemnified Party" and collectively, the "Indemnified Parties") from and against any and all claims, demands, actions, judgements, liabilities, damages, losses and expenses, whether in law or in equity, including but not limited to attorneys', paralegals', consultants', and experts' fees, costs and expenses, arising from or relating to this Agreement and/or the Project, whether such claims, actions, liabilities, damages, losses or

expenses arise prior to or following termination or expiration of this Agreement, except to the extent any liability, loss, cost or expense is caused by the Indemnified Party's sole negligence or willful misconduct.

- Defense. If requested by the Indemnified Party, the Indemnifying Party shall 3.3 assume on behalf of the Indemnified Party, and conduct with due diligence and in good faith, the defense of such Indemnified Party with counsel reasonably satisfactory to the Indemnified Party. If any claim, action, proceeding or investigation arises as to which the indemnity provided for in this Section 3.3 applies, and the Indemnifying Party fails to assume the defense of such claim, action, proceeding or investigation after having been requested to do so by the Indemnified Party, then the Indemnified Party may, at the Indemnifying Party's expense, contest or, with the prior written consent of the Indemnifying Party, which consent shall not be unreasonably withheld, settle such claim, action, proceeding or investigation. All costs and expenses incurred by the Indemnified Party in connection with any such contest or settlement shall constitute CCWA Costs pursuant to this Agreement and shall be paid upon demand by the Indemnifying Party. Notwithstanding anything to the contrary herein, CCWA shall be entitled to hire independent counsel to defend any such action. Additionally, any and all costs, expenses and attorneys' fees incurred by CCWA and its counsel in defending such action shall constitute CCWA Costs pursuant to this Agreement and shall be paid upon demand by the Indemnifying Party.
- **Remedies.** If Solstra does not timely perform its obligations pursuant to this Agreement, CCWA shall be entitled to proceed to protect and enforce its rights as provided in this Agreement by such appropriate judicial proceedings as CCWA shall deem most effectual, either by suit in equity or by action at law, whether for the specific performance of any covenant or agreement contained herein or to enforce any other legal or equitable right vested in CCWA by this Agreement or by law. The provisions of this Agreement and the duties of Solstra and of its officers, agents, or employees shall be enforceable by CCWA by suit, action, or proceeding in any court of competent jurisdiction.

5. <u>Term; Termination</u>

5.1 Term. The term of this Agreement shall commence on the date upon which executed by all Parties ("**Effective Date**") and shall continue until terminated as provided for herein.

5.2 Termination of Contractual Rights; Continuing Obligations.

- 5.2.1 Upon Solstra's failure to make any deposit or payment which failure constitutes an un-cured default under this Agreement, CCWA may terminate this Agreement. Regardless of such termination, the obligations of Solstra to CCWA to pay CCWA Costs under this Agreement shall continue in full force and effect.
- 5.2.2 This Agreement may be terminated by Solstra upon the expiration of thirty (30) days following the later of (i) delivery of written notice of termination to CCWA, and (ii) discharge by Solstra, or satisfactory performance of all financial obligations hereunder.
 - 5.2.3 Sections 3 and 4 shall survive termination of this Agreement.

6. General Provisions

- **6.1 Assignability.** This Agreement shall not be assigned by Solstra without the prior written consent of CCWA, which consent shall not be unreasonably withheld. Any attempted assignment without the prior written approval of CCWA shall be void.
- 6.2 Counterparts; Electronic Signatures; Delivery by Email. The Agreement may be executed in two or more counterparts, each of which shall be deemed an original, and all of which when taken together shall constitute one and the same document. Counterparts may be delivered via electronic mail (including PDF or any electronic signature complying with the federal Electronic Signatures in Global and National Commerce (ESIGN) Act of 2000 (P.L. 106-229), e.g., www.docusign.com) or other transmission method and any counterpart so delivered shall be deemed to have been duly and validly delivered and be valid and effective for all purposes.
- **6.3 Due Authority.** The individuals executing this Agreement represent and warrant that they have the authority to enter into this Agreement on behalf of their respective party and to bind that party to perform all acts required by this Agreement, and that the consent, approval, or execution of or by any additional person or party is not required to legally bind that party to the terms and conditions of this Agreement.
- 6.4 Entire Agreement; Modification. The making, execution and delivery of this Agreement have not been induced by any representations, statements, warranties or agreements other than those herein expressed. This Agreement constitutes the entire agreement and understanding of the Parties concerning the subject matter hereof. This Agreement supersedes all prior negotiations, agreements, representation and understandings of the Parties relating to the subject matter hereof. No supplement, modification or amendment of this Agreement shall be binding unless executed in writing by all of the Parties.
- **6.5 Governing Law; Venue.** This Agreement and all matters relating to this Agreement shall be governed by the laws of the State of California, without regard to principles of conflicts of laws. Venue for any disputes under this Agreement shall be in Santa Barbara County, California.
- **6.6 Legal Advice**. Each Party has received independent legal advice from its attorneys with respect to the advisability of executing this Agreement and the meaning of the provisions of this Agreement.
- **6.7 No Agency.** This Agreement shall not create, nor shall it be construed to create any agency, partnership or similar relationship among the Parties.
- **6.8 Notices.** All notices, approvals, acceptances, requests, demands and other communications required or permitted under this Agreement, to be effective, shall be in writing and shall be delivered, either in person or by email or by Federal Express (or other similar overnight delivery service) to the Authorized Representative of the Party to whom the notice is directed. Any communication given by email shall be deemed delivered on such mailing date and any communication given by overnight service shall be deemed delivered one (1) business day after the dispatch date. Any Party may change its email and overnight service addresses by giving all other Parties written notice of the new address(es).

6.9 Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the Parties hereto and their respective successors and assigns.

SUBJECT: FY 2024/25 Second Quarter Investment Report

SUMMARY

Attached is the second quarter FY 2024/25 investment report covering the three-month period of October to December 2024. In accordance with the CCWA Statement of Investment Policy, the quarterly report includes a statement of compliance of the portfolio with the investment policy and confirmation of the Authority's ability to meet expenditure requirements for the next six months.

DISCUSSION

As of December 31, 2024, the investment portfolio totaled \$61.8 million and had an effective rate of return of 4.13% with an average daily balance for the month of December 2024 of about \$57 million. The investments were comprised of Montecito Bank & Trust money market accounts of \$1.4 million, and Charles Schwab market funds of \$60.4 million.

All investments during the quarter complied with the CCWA investment policy provisions.

CASH MANAGEMENT PRO FORMA PROJECTIONS

Current pro forma projections indicate that the Authority will have sufficient cash with which to operate for the next six months.

RECOMMENDATION

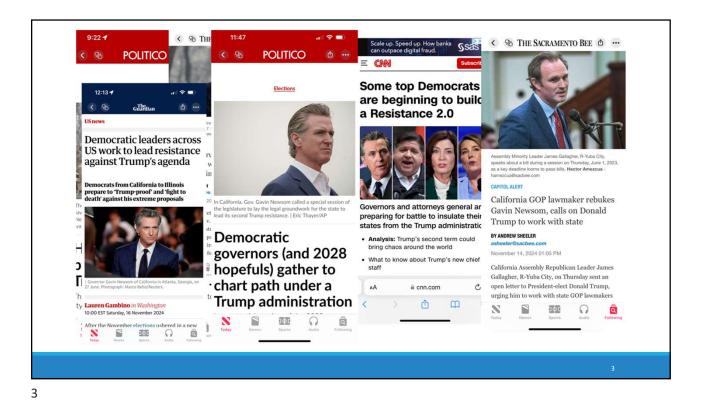

State Legislature

- · January 6: Legislative session resumed
- January 10: Governor submitted proposed State Budget
- January 24: Legislative Counsel deadline for submittal of bill requests
- February 21: Bill introduction deadline
 - Reduced bill introduction limits for Assembly and Senate (Assembly 50 → 35) (Senate 40 → 35)
 - Net reduction of 1,400 bills introduced per 2-year legislative session

Special Session of State Legislature

- On November 7 Governor Newsom called special session to commence on December 2
 - Objective of special session is to "Safeguard California Values"
 - Purported focus is to approve funding for the DOJ and other state agencies to "immediately file affirmative litigation"
- Legislative proposal
 - \$25 M to Attorney General for litigation immigration, reproductive rights, climate policies
 - \$25 M in grants for legal aid services
 - New website and reporting tools to track litigation
- Timing
 - Originally expected to be heard in Legislature on January 12 and quickly resolved by Legislature
 - · Wildfire events have postponed action for near-term

Governor's Proposed State Budget

- On January 10, the Governor released the proposed State Budget for 2025-26
 - \$322 billion (2nd largest state spending plan ever)
 - General Fund spending = \$229 billion
 - Revenues above projections by \$16.5 billion
 - Modest surplus = \$363 million
- Top line programmatic priorities
 - · Affordability across all areas
 - · More efficient and leaner government
 - Keeping California safe, clean, and accountable

Governor's Proposed State Budget - Climate Spending

- State Budget proposes \$2.7 B for first year of a multi-year bond expenditure plan
 - Water-related infrastructure investments
 - \$231.5 M for dam safety projects and reservoir operations
 - \$183.2 M for water quality and safe drinking water
 - \$173.1 M for flood control
 - \$153.4 M for water reuse and recycling
 - \$176 M for fish and wildlife resources protection and enhancement
 - \$148.2 M for Salton Sea Management Program
 - \$19.9 M for invasive species projects and activities
 - \$273 M proposed shift from prior General Fund obligations to climate bond (\$98 M in dam safety and water recycling funding)
- Non-bond funding proposals include:
 - \$173.5 M for improving water storage, replenishing groundwater, improving conditions in streams and rivers, and completing various water resilience projects

Governor's Proposed State Budget – Questions Remaining

- Proposed State Budget does NOT include a proposal for allocation and use of funding from the Greenhouse Gas Reduction Fund (cap-trade revenues)
 - The Administration and Legislature "will need to consider extending the cap-and-trade program beyond 2030 to achieve carbon neutrality. Although the current cap-and-trade program does not expire until 2030, considering extension sooner could provide greater certainty and attract stable investment."



- \$230 M is currently programmed through the GGRF for completion of the Oroville pumped hydropower project over coming budget cycles
- How will Administration and Legislature respond to the LA wildfires through budget actions over the Spring and into the May Revise?

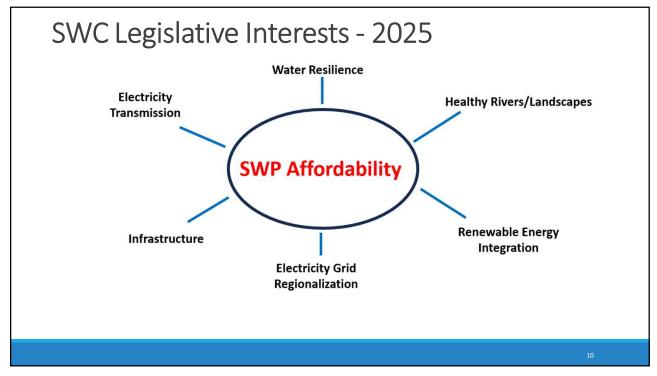

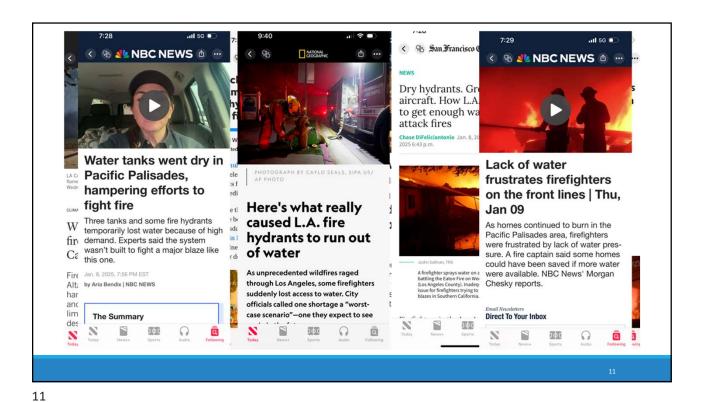
